Provided that old members shall be eligible to vote on completion of one year of their enrollment and payment of all dues.
- Members of election commission are: Mr. Noman Soomro (Chairman Election Commission), Mr. Noman Qurban (Member) and Mr. Muhammad Kamran Ahmed (Member). They have submitted their consent in writing. They haven't been office bearers of MUFAP for the past two years and are not candidates to the election. They are independent and impartial and do not canvass for any of the candidates or panels contesting the elections.
